### **Agreement between user and Doryeshorim.org**

Welcome to Doryeshorim.org. The Doryeshorim.org website (the "Site") is comprised of various web pages operated by Dor Yeshorim. Doryeshorim.org is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms").
